# Why Is It Required?



*Federal Government provides funding to serve as an impetus for adoption of new strategies at the local level.*



*Recipients have a stake in knowing that they are helping themselves by contributing and investing in the concept.*

# What is required?

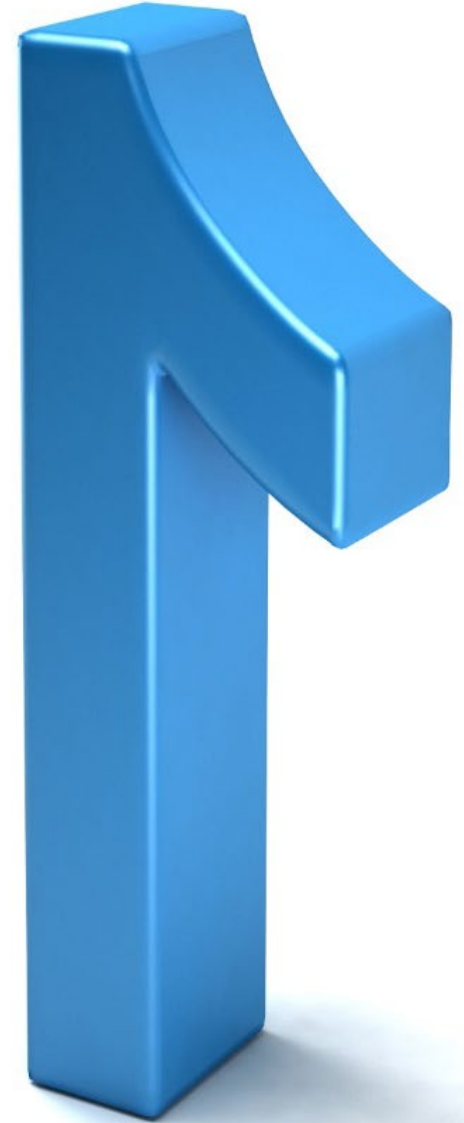
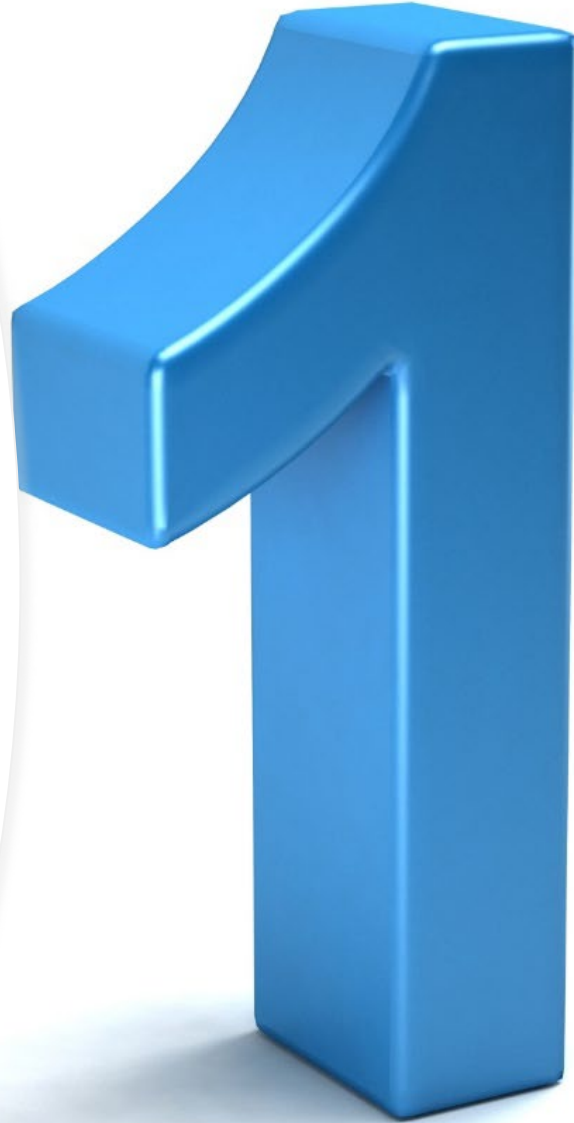




# SRT BWC Requirements

---

- It is a dollar-for-dollar match.
- If the grant is for \$10,000, then \$10,000 *in value* must be contributed.



# How is it Achieved?

- Cash (Hard)

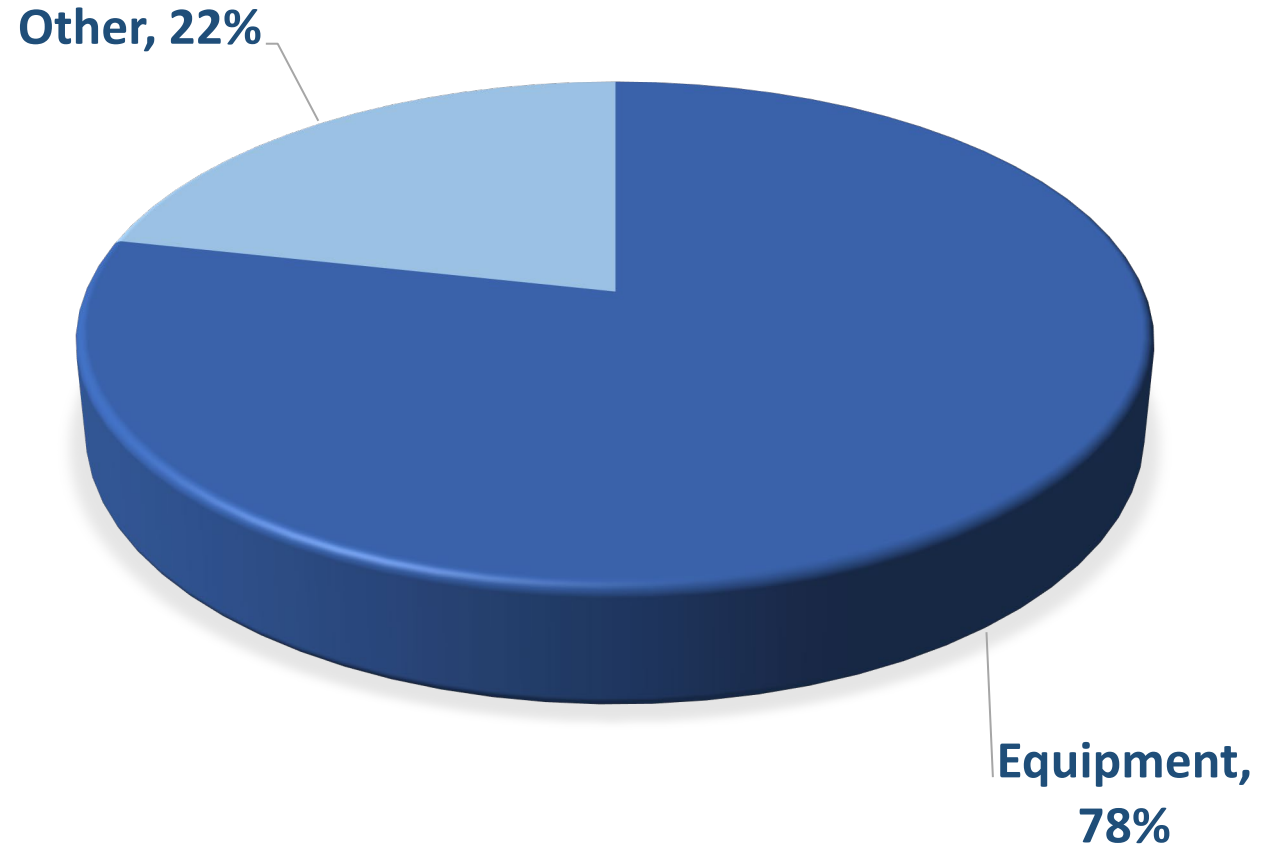
AND/OR

- In Kind (Soft)



# SRT BWC Micro-grantees Match Funds by Type

- Micro-grantees (n=385)
- Match Types
  - Equipment/Supplies
  - Other
    - Personnel
    - Consultants
    - Miscellaneous (Infrastructure enhancements, etc.)



# Cash Examples

- Equipment
- Technology costs



# In Kind Examples

- Personnel time that is 'extra' or additional to the project that would not ordinarily occur
- Time spent by officers in training
- Civilian/officer administrative time in installation/ management

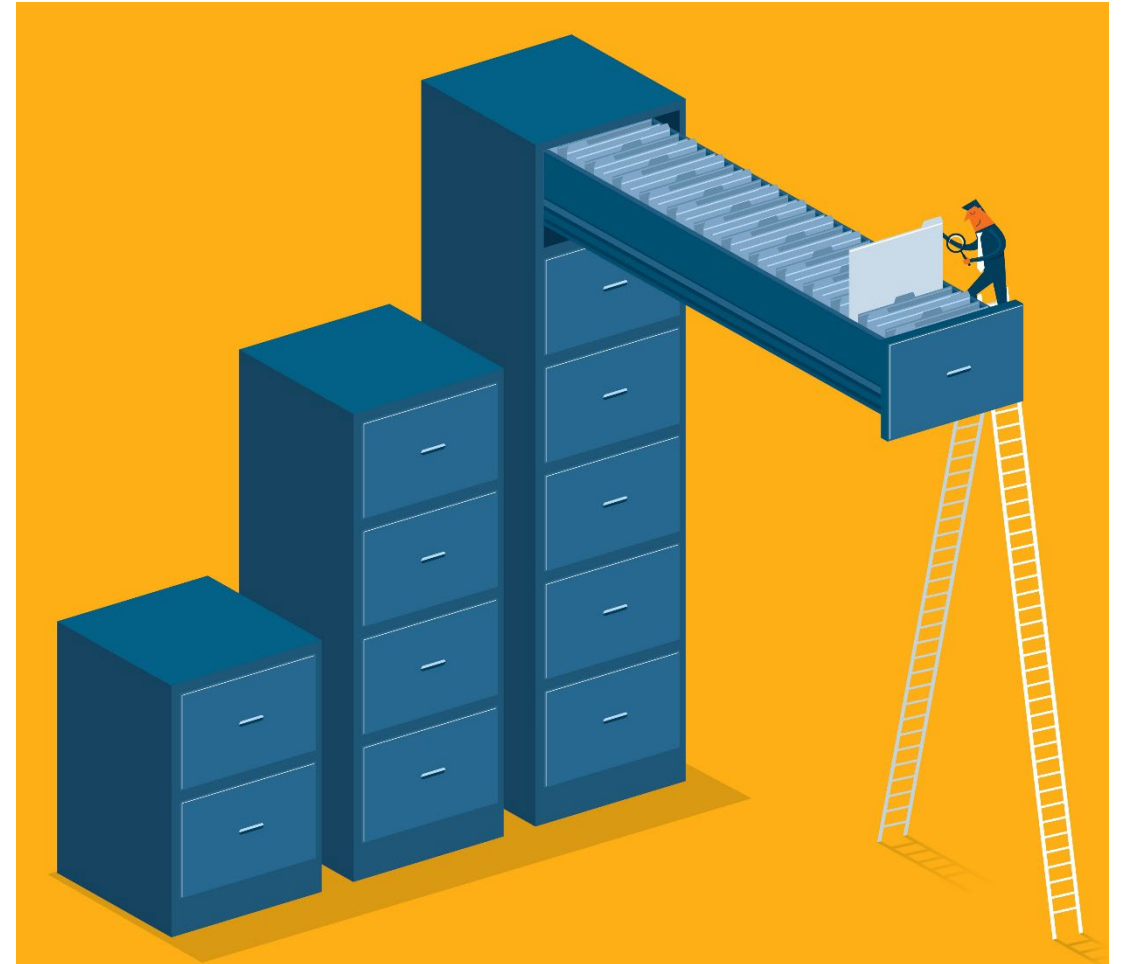

- *Paperwork on file for **seven** years*

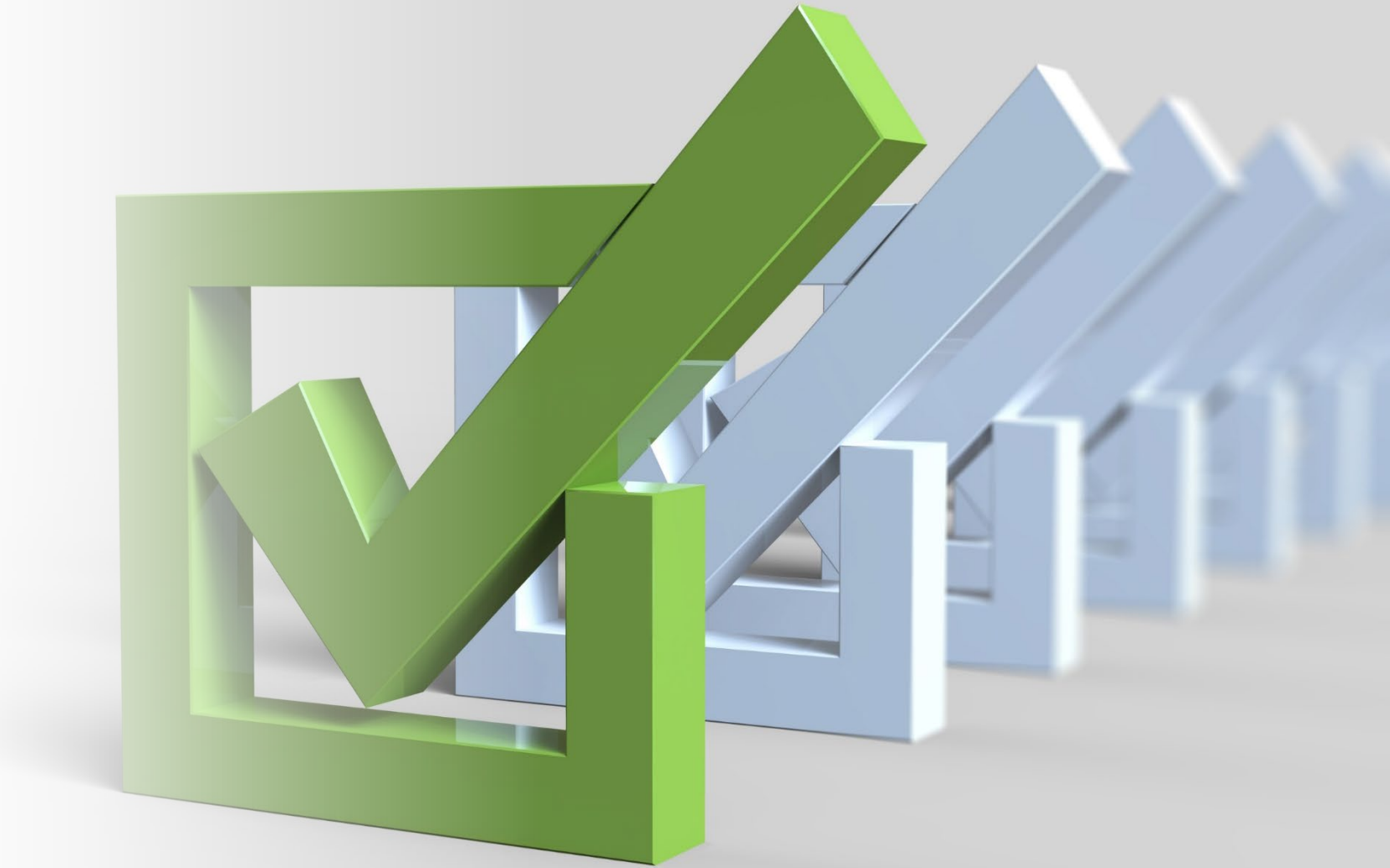


# Win – Win Match Process
