FY 2023 Connect and Protect: Law Enforcement Behavioral Health Response Program

This grant funding program assists law enforcement agencies and behavioral health organizations to collaborate to improve public health and safety. In particular, it provides funds for agencies to respond to and assist individuals with mental health disorder or co-occurring mental health and substance use disorders.

Success Story: Warren County Sheriff's Office, KY

Agency Information: Small agency with 45 full-time officers. They requested 45 BWCs and were awarded \$90,000. They are implementing a new BWC program, and their success story was reported in November 2022.

"We have received many compliments from our deputies in the usefulness of the body worn cameras. Several deputies have said that when they let people know during interactions that what they say and do is being recorded it seems to modify their behavior in a positive way. Additionally, the recordings have assisted in the gathering of evidence by recording statements and/or actions of those committing crimes."
